## **Coronavirus Disease 2020 (Covid-19)**

Thank you to our Valued Business Partners, Employees, and Contractors. As we continue to upgrade our Covid-19 Pandemic Response Plan across our organization, we have added steps to improve our health and safety protocols.

We wanted to personally share an update on our efforts to help keep our operations up and running during the Coronavirus (COVID-19) Pandemic.

Wise Plastics Technologies has entered into Phase 4 of Illinois' "***Restore Illinois: Guidelines to Reopening for Manufacturing.***" As such, we have implemented several steps into our daily operations:

- The use of ***Thermographic Temperature Scanners*** to check temperatures of employees, contractors and visitors coming into the building
- Everyone must wear a face mask when entering and exiting the building, and throughout the day
- Extension of work stations to promote Social Distancing
- Scheduled cleaning/sanitizing of work machinery and frequent traffic areas using disinfectants approved by CDC and EPA

As travel restrictions have loosened during Phase 4, we constantly monitor both the CDC and the Department of Public Health for updates to their policies.

Recently, on July 6, 2020, a *Travel Restriction Order* was issued by the City of Chicago. Although not in Chicago, we have chosen to err on the side of caution and follow their guidelines. Anyone, including employees, contractors, and visitors, who travel to or from a state experiencing surges of positive Corona Virus Tests, must self-quarantine for 14 days or self-quarantine till receiving a Negative Covid-19 Test before being allowed to enter our facility.

This measure is in response to increased and high rates of COVID-19 transmission in certain states. Although Illinois is not one of the listed states, we've worked very hard at Wise Plastics Technologies to limit potential exposure to Covid-19 while at home or at work. The quarantine requirement applies to people even if they have no symptoms of COVID-19.

Our goal at Wise Plastics Technologies has always been to provide a place of work where we all are as safe as possible. For close to six months now we've been laser-focused on containing this virus and limiting infections, and we've made tremendous progress. That remains our focus today, and this order is another important measure in helping us further contain the spread of COVID-19.
